The **Global Reporting Initiative (GRI)** is the most widely used sustainability reporting standard. This training course will prepare participants to manage their sustainability reporting process using the GRI Standards and will introduce them to all the key elements of a solid sustainability report. First-time reporters seeking to implement the GRI Standards and experienced reporters integrating GRI Standards with other international standards, will learn how to effectively utilise the Standards and develop sustainability Reports that are technically sound, meaningful, engaging, and create value for the company and the stakeholders alike.
