Description: This is an updated version of a policy brief first published in September 2019 (last updated June 2020). The brief originally examined the impact of climate-related policy on a sample of 366 of the world's biggest companies, worth \$28 trillion in market cap, as disclosed through the CDP platform in 2018. We have now added a second part, consisting of an analysis of companies' readiness for disclosure legislation, based on a broadened sample of 2,376 companies.



Description: In a unique new report, CDP has worked with University College London (UCL) Energy Institute to help us understand the potential costs to global Gross Domestic Product (GDP) of failing to realize a 2 degrees Celsius aligned scenario. The report models the mean damage costs of 'business as usual' action on climate change at \$5.4 trillion USD a year by 2070 and \$31 trillion USD a year by 2200.
